MONTHLY BIDDABLE INJECTION SERVICE AUGUST 2020

TransGas is pleased to advise that it will offer firm injection capacity for the month of August 2020.

This firm storage injection capacity, for this upcoming injection month, will be available as a "bid for" service with a minimum bid level of \$0.04 /GJ/month. For August 2020 service, bids will be accepted until 12:00 p.m. Saskatchewan time, Tuesday July, 28th, 2020 and you will be notified if you will receive any of this incremental service by the end of the following working day. The bid rate will be charged as a demand rate applied to the awarded level of injection capacity.

The firm storage injection capacity available for the period of August 01, 2020 to August 31, 2020 is 20 TJ/d. The August – October firm storage injection capacity offered in the seasonal biddable firm storage injection service (SFIS) is still available on a first come, first serve basis.

TransGas will allocate the available capacity based on the highest total bid revenue and notify bidders the business day following the close of the bid window as to whether the bid has resulted in an award of service. In awarding the service, if two bids of equal value are received and there is not capacity to fill both bids, the available capacity will be prorated among the equal bids. Bidders will not be forced to accept prorated amounts less than their full bids.

Attached is a standard TransGas bid form for your review and use to take advantage of our biddable firm injection service.
