NON-STANDARD STORAGE SERVICE OFFERING

TransGas Limited (TransGas) hereby announces a non-standard **binding first-come-first-serve** offering for Storage Services. This offering is being conducted pursuant to the terms and conditions contained within the TransGas Comprehensive Tariff and the terms and conditions set out herein. The Capacity, term, and conditions that apply to this offering are as shown in the attached offer sheet. This full-season offering is available to start at any date between August 19, 2020 and October 1, 2020 (inclusive) with an end date of April 30, 2021.

This storage service offering will be contracted under TransGas' summer use interruptible storage rate category (S-49.0), and follows the convention of the S-49.0 rate with additional conditions as required to reflect the terms and conditions outlined.

The offer window of this binding first-come-first-serve offering commences at 9:00 a.m. Saskatchewan time on August 17, 2020 and will close on September 29, 2020 at 12:00 p.m. (noon) Saskatchewan time or until all the capacity offered has been allocated. Interested parties are invited to complete the attached offer sheet and return it to TransGas through an email to tglcustomerservices@transgas.com, aschmidt@transgas.com, and atulloch@transgas.com within the offer window. This will timestamp the request to fairly award the service on a first-come-first-serve basis. TransGas will acknowledge receipt of the offer sheet, and will inform the interested party of their allocated capacity.

- Rate: S-49.0, Summer Use Interruptible

- Withdrawals or transfers from this storage service will not be allowed during the period from the start date to March 31, 2021;
- Inventory must be removed from this storage service by the end of the term of service (April 30, 2021);
- This service does not have renewal rights.

This storage service will be allocated to parties on a **first-come-first serve basis** until the one (1) PJ of storage capacity has been allocated or until the close of the offer window.

We ask that you give TransGas no fewer than two (2) business days from the offer sheet submission to the start date of the term of service. Please contact your KAM if this timeline cannot be met.

TransGas will acknowledge receipt of the offer sheet, and will inform the interested party of their allocated capacity. TransGas will enter a Request for Service (RFS) confirming this service request.
