Shipper hereby agrees to indemnify and save harmless TransGas from any losses, demands, claims, costs or expenses that it may incur or that may arise due to TransGas' reliance upon the Nominating Agent's authority.

The parties further agree that the Nominating Agent accepts full responsibility to comply with requests from TransGas in relation to those matters within the scope of the Agreements' authority, more specifically set out above.

This appointment of Nominating Agent shall be effective \_\_\_\_\_ and shall remain in effect until the earlier of:

- 1) written notice of termination of the agency appointment is received by TransGas from Shipper;
- 2) written notice is provided by TransGas to Shipper terminating the Agent's appointment due to default; or
- 3) the expiration of the Agreements.

This Nominating Agency Agreement shall be governed by and construed in accordance with the laws of the Province of Saskatchewan. Nothing herein contained shall release Shipper from any of its obligations, agreements, covenants, representations or warranties contained in the applicable Agreements.

The uppercase terms used herein shall have the same meanings as are ascribed to the corresponding terms in the Definitions section of the [TransGas Comprehensive Tariff](#), unless otherwise defined herein.
